



Where should we begin! It has been almost a year now since our last benefit shoot. Let us start by telling you our journey. We are the Harvey's, Kevin, Chantel, Kobe, and our six year old son Devin. For those of you that don't know Devin, he was a young boy, full of life and so outgoing. Devin was diagnosed with Adrenoleukodystrophy (ALD) in May of 2013. ALD is a rare genetic disorder that causes damage to the myelin sheath, an insulating membrane that surrounds nerve cells in the brain. The childhood cerebral form is the most severe, with onset between 4-10 years old. The most common symptoms are usually behavioral changes such as abnormal withdrawal or aggression or poor school performance. Other symptoms include vision loss, learning disabilities, seizures, deafness, and fatigue. There is no cure for this disease. Prognosis is generally poor due to progressive neurological deterioration unless a bone marrow transplant can be performed in the early stages. Devin's prognosis was estimated to be 18-24 months.

Our hope a year ago was that an experimental Mesenchymal Stem Cell transplant was going to stop the progression of his disease. Devin underwent a transplant in July 2013. In September, after several MRI's, we found out the disease was still progressing. The Doctors in Minnesota then wanted to try a drug called Tysabri which is used for Multiple Sclerosis. Devin was on the drug for four months, with one infusion every four weeks. During the Tysabri treatments we flew to Muscat, Oman for another experimental stem cell treatment. As time passed Devin was beginning to regress more and more. Devin had completely lost his vision and his hearing was getting worse by the day. As parents we were devastated knowing where he was headed. After putting Devin to sleep at night we would stay up praying, studying the disease, and hoping to find our next step if all this had not worked. The next MRI came in November and again the disease was still progressing. This news only made us angrier knowing this disease was taking over our son's body and there was nothing we could do. We weren't stopping. We found another clinic in Cancun where they specialize in using autologous stem cells with growth factors. This procedure was performed in late November. By January his ability to walk was also taken away and his speech was very slurred from the progression of this disease. In February his speech and his ability to swallow was taken, so we decided to have a feeding tube placed at Children's Hospital. Devin was on multiple medications four times a day. He was having tremendous amounts of pain from the muscle spasms. A feeding tube was our only option to get his medication down and keep him comfortable. While in Cancun, we had found another clinic that specialized in gene therapy. Gene therapy is the use of DNA as a drug to treat a disease by delivering therapeutic DNA into a patients cells. A treatment that could perhaps put the gene Devin was lacking, which is the ABCD1 gene, back into his body via lumbar puncture and stop the disease for good. This doctor was contacted while in Cancun and he said he would accept Devin's case. The Gene Therapy would take up to 8 weeks to grow. Devin had this procedure at the end of February in Bogota, Columbia. This treatment could take up to six months to work. Devin had an 8 week post therapy MRI done and it still showed progression. We have not given up hope and are praying hard that this therapy just needs more time to fully do its job. While this gene therapy is doing what it is designed to do, we are still researching for that next step. The next step would be remyelination of the brain but unfortunately this is not being researched for ALD. Seems like the stopping point but we can't stop now. We will pursue every option we can for our loving son Devin.

Thanks for all the generosity and support everyone has given in this difficult time in our lives. We appreciate everything everyone has done and is doing for our family.
